Educational Resources

Thank you all for meeting with the HEPC/CTCS on November 9 and November 17, 2021, to discuss implementation of HB 2853 mandating expansion of Open Education Resources (OER) for West Virginia public colleges and universities. We agreed that each campus would implement a system to identify OER courses in the semester course schedules. Specifically:

- For fall 2022 course schedules, each campus will at the minimum, publish a list
 of OER courses being offered that semester in the semester course schedule
 and in a location easily accessible to students. Campuses that can ID individual
 OER courses at this point in time are encouraged to do so.
- For Spring 2023 course schedules, each campus will ID individual OER course
 offerings in the semester course schedule and initiate efforts to make students
 aware of the OER course designations.
- The current definition for Open Educational Resources Courses is \$75.00
 (dollars) or less for instructional materials. Technical costs such as proctors or a
 campus mandated lab fee are not included as instructional materials. Open
 Educational Resources (OER) will be used as the term to designate low cost and
 no cost courses. This definition will be reviewed from time to time.
- This legislation mandates an annual report to the West Virginia Legislature. The first report is due on June 30, 2022. This report shall include but not be limited to the number of OER courses being offered, the number of students taking OER courses, the individual saving per student in OER courses and the aggregated savings for all students in OER courses. Savings costs shall be determined using the campus bookstore price for the traditional textbook.
- The HEPC/CTCS Data and Policy Office shall meet with institutional research representatives from the various campuses during the spring 2022 semester to create and/or refine reporting procedures related to this legislation.
- This group agreed to meet again during the spring semester of 2022 to review processes and discuss continued implementation of this statute.

Two longer term goals were discussed:

- For two-year institutions, create full OER degree programs. Referred to as "Z" degrees, these degree programs utilize open educational resources for every class in the program curriculum.
- For four-year institutions, create a pathway where students could take all general education courses as open educational resource offerings.

Thank you again for meeting with us. As the program moves forward, we also want to examine such factors as completion and retention rates for OER courses compared to traditional textbook courses. In the meantime, we look forward to working with you during the implementation phase of this legislative mandate.
